III. Presentation and evaluation of Town Hall results and BLVD. 20/20

Tootie Thanked all that were involved and partnered with the ECBBIA in putting on the event at The Rock. Special thanks to MAry Lydon of Housing You Matters for being involved from the start. Mary is introduced as todays facilitator of the BLVD. 20/20 Board working group. Tootie opens the floor for discussion on the event and its highlights including a larger than expected crowd, Audience and residents really enjoyed the format, guest speakers, live feed from NYC and opportunity to weigh in. Mary Lydon starts the session by inviting deeper thought by board members into what their questionnaire responses were and where they match up with community input.
